

# Expanded Practice Protocol for the Clinical Nurse Specialist Uro-Oncology Led Review Clinic for Patients who are Undergoing, or have Completed Radical Radiotherapy for a Bladder or Prostate Malignancy

### **EVIDENCE FOR PRACTICE**

In line with the Department of Health Strategy for Cancer (2011), all patients with the diagnosis of cancer should have access to a named registered nurse specialist. The registered nurse specialist is in the ideal position to review this group of patients because they have had contact with the patient since referral to the specialist team and throughout their subsequent investigations, diagnosis and treatment.

According to the National Cancer Action Team (2010), the registered nurse specialist provides a service that ensures that each patient receives continuity of high quality and compassionate care, which is specific to individual needs.

Before the clinical nurse specialist - uro-oncology led review clinic was commenced, patients undergoing radiotherapy experienced long waits to be seen by junior medical staff. By providing a clinical nurse specialist - uro-oncology led review clinic, patients are seen on time, which assists in improving the overall experience throughout the patient journey.

A review of the expanded practice protocol has been undertaken to ensure the practice covered by this document remains up to date. As part of this review, an audit was undertaken (Gledhill, 2017), which has confirmed that the expanded practice protocol has been adhered to. No significant changes to the protocol have been made.

### CONSENT

Although formal written consent is not required for minor procedures, verbal consent for review in the clinical nurse specialist - uro-oncology led clinic must be obtained where possible and this must be documented in the patient's records. For further information regarding consent and mental capacity please refer to the following documents:

- Department of Health Reference Guide to Consent for Examination or Treatment (2009).
- The Trust's Policy and Procedural document for consent to examination or treatment (current version).
- Mental Capacity Act (2005).

### **INDICATIONS**

- 1. The patient who has been diagnosed as having either bladder or prostate malignancy and is receiving radical radiotherapy.
- 2. The patient who has completed their treatment for a bladder or prostate malignancy, and has been selected by the oncology consultant/specialist registrar, as suitable to attend the clinical nurse specialist uro-oncology led follow up clinic for patients who are undergoing or have completed radical radiotherapy for a bladder or prostate malignancy.
- 3. The patient must be seen by the uro-oncology consultant/specialist registrar to discuss radiotherapy prior to commencing treatment. The

patient will be seen weekly thereafter, by the clinical nurse specialist - urooncology, throughout their radiotherapy treatment regime.

4. An oncology consultant or specialist registrar must be available for consultation during the clinic.

### 5. For patients with prostate cancer:

The clinical nurse specialist - uro-oncology must ensure the patient has a follow up appointment with the uro-oncology consultant 3 months after the end of treatment, and must arrange for the patient to have a prostate specific antigen (PSA) blood test performed 2 weeks before the appointment.

### 6. For patients with bladder cancer:

The clinical nurse specialist - uro-oncology must arrange a rigid/flexible cystoscopy with the patient's consultant urologist 3 months from the completion of treatment. The clinical nurse specialist - uro-oncology must also ensure the patient is booked for a CT scan of chest, abdomen and pelvis.

Following these investigations, the uro-oncology registered nurse must then schedule the patient for review by the Multi-Disciplinary Team.

### **CONTRAINDICATIONS**

- 1. The patient is under 16 years of age.
- 2. The patient has capacity and does not give consent to be reviewed at the clinical nurse specialist uro-oncology led follow up clinic for patients who are undergoing or have completed radical radiotherapy for a bladder or prostate malignancy.

### LIMITATIONS TO PRACTICE

- 1. If there have been significant problems or issues with the treatment, then the patient must be seen jointly by the clinical nurse specialist uro-oncology and consultant uro-oncologist/ specialist registrar at the end of their radiotherapy treatment regime.
- 2. The patient who is experiencing severe side effects with the radiotherapy treatment. In this case the registered nurse specialist must immediately seek the advice of the consultant oncologist/specialist registrar to discuss further management.
- 3. If the clinical nurse specialist uro-oncology is concerned about the patient's condition they must immediately refer the patient to the consultant oncologist/ specialist registrar for advice on any further action to be taken, and this must be recorded in the patient's records.

The appropriate Health and Safety risk assessments must have been completed for the clinical area.

### CRITERIA FOR COMPETENCE

- A clinical nurse specialist uro-oncology, with knowledge of prostatic and bladder disease management, who must have undertaken education and training recognised by their line manager.
- 2. Evidence of satisfactory supervised practice must be provided by the clinical nurse specialist uro-oncology as witnessed by a practitioner (i.e. consultant oncologist) who is competent in the management of this group of patients (Appendix 1).
- 3. The number of supervised practices required will reflect the individual clinical nurse specialist uro-oncology's learning needs.
- 4. Evidence of competence must be provided and a copy kept in the clinical nurse specialist - uro-oncology's personal file and in the department where the skill is practised (Appendix 2). Following each review and update of the protocol the clinical nurse specialist - uro-oncology has a responsibility to ensure that they have read and familiarised themselves with the current version of the protocol.
- 5. Clinical nurse specialists uro-oncology new to the Trust, who have been performing leading the clinics elsewhere, must read, understand and be signed off against this protocol. Evidence of appropriate education and competence must be provided and checked by their line manager before undertaking this expanded practice at the Trust. The decision whether the clinical nurse specialist uro-oncology needs to complete Trust training will be at the discretion of the line manager.
- 6. In accordance with codes of professional practice, the clinical nurse specialist uro-oncology has a responsibility to recognise, and to work within, the limits of their competence. In addition, the clinical nurse specialist uro-oncology has a responsibility to practise within the boundaries of the current evidence based practice and in line with up to date Trust and national policies and procedural documents. Evidence of continuing professional development and maintenance of skill level will be required and confirmed at the clinical nurse specialist uro-oncology's annual appraisal by their line manager.

A list of clinical nurse specialists - uro-oncology competent to lead this clinic must be kept by the line manager.

### PROTOCOL AND SKILLS AUDIT

The Lead Clinical nurse specialist - uro-oncology will lead the audit of the protocol with support from the Practice Development Team. The audit will be undertaken in accordance with the review date, and will include:

- Adherence to the protocol
- Any untoward incidents or complaints.
- Number of registered nurses competent to lead the clinic.
- Patient satisfaction feedback.

All audits must be logged with the Risk and Compliance Unit using the Clinical Audit Registration and Management System (CARMS).

### CLINICAL INCIDENT REPORTING AND MANAGEMENT

Any untoward incidents and near misses must be reported via the Trust incident reporting system, and where required escalated to the appropriate management team. In addition, the Risk and Compliance Unit must be notified by telephone of any Serious Incidents (SI).
