Yes. The Car Parking and Traffic Management services at QEHB are operated by a private sector company, Consort Healthcare (Birmingham), as part of a wider PFI contract. The day to day management of Trust car parks at QEHB is undertaken by Q-Park Ltd.

Q-Park Ltd receives a) 0% of staff parking income and 100% of visitor parking revenue and b) 100% of parking fine income.
