

## Freedom of Information Request: FOI 0277

University Hospitals Birmingham NHS Foundation Trust (UHB) completed a merger by acquisition of Heart of England NHS Foundation Trust (HEFT) on 1<sup>st</sup> April 2018. Due to historical differences in data collection/reporting across UHB and the former Heart of England NHS Foundation Trust this response has been provided by hospital site.

I am writing to you to request the following information from the Trust under the Freedom of Information (FOI) Act 2000 (the Act);

1. An estimate of the population the Trust's remit covers.

The Trust treats more than 2.2 million patients each year and serves a regional population of over 1.8 million people. We also provide a series of highly specialist services to patients from across the UK and internationally.

The Trust does hold the information you have requested, however we estimate that compliance with your request would exceed the appropriate costs limit under section 12 of the Freedom of information Act 2000. This is currently £450. The appropriate limit would be exceeded if it would require more than 18 hours work.

There are certain staff groups where it is very easy to determine whether they are working in a clinical or non-clinical capacity. However, there are other staff groups where the only way of ascertaining this would be to go through each individual job to determine this, which would exceed 18 hours.

As above, The Trust does hold the information you have requested, however we estimate that compliance with your request would exceed the appropriate costs limit under section 12 of the Freedom of information Act 2000.
