

Freedom of Information Request: 0445 2019/20

Does your NHS Trust organise, pay for and carry out public health / hospital contract funerals for people who die in the trust's care and who don't have the financial means or family/friends to arrange it?

Please note that The Trust has an ongoing agreement with Birmingham City Council's, Funerals and Protection of Property department. Funerals and Protection of Property provide dignified, sensitive funerals for those who do not have anyone willing or able to make suitable arrangements following their death. We pay for some funerals if the person did not have any assets or funds but not all, the cost may vary as some funds may have been recovered from the deceased estate.

Funerals and Protection of Property investigate into a number of aspects regarding each death referred to them, these include locating any available finances, a search of the deceased persons property and the services of a Genealogist to trace and confirm any next of kin. Funerals and Protection of Property will then inform them of the death and provide an opportunity to take over or be involved in funeral arrangements. Therefore not all deaths referred to Funerals and Protection of Property by the Trust result in a public funeral.
