	KPI 18.1 to 19.1.3.4	Agreed Method of monitoring – wording removal of Monthly and Quarterly		
	KPI – 18.1	Laboratory Medicine requires that the courier company monitor performance against the agreed standards and report any issues and actions to Laboratory Medicine on a Bi-monthly basis. However, this is not restricted to communicating issues outside of scheduled meetings or by exception.		
	KPI – 18.2.1	HEART01 - go back to weekly SLA reporting so the 'rolling period' is compliant. HEART 02 Report checking time of booking requested verses collection time from location.		
	KPI – 19.3.1	HEART 01 A/c: There is a tolerance of 15minutes in which the Provider calls the duty on-call Manager. Failure to call within this tolerance and the KPI is triggered.		
	KPI – 19.3.2	HEART 04 A/c; "In-Hrs" 15minute tolerance from schedule time to notify the duty on-call manager. Failure to collect within the hour triggers the KPI. "out of hours"; 30 minute tolerance from scheduled collection time to notify the duty on-call manager. In the event of a failure to service HEART 04 requirements under performance against contract a request for 'ad-hoc' collection may be required - this will be at no extra cost to the trust. If neither the scheduled collection or adhoc collection happens within 90minutes of the original schedule run. The KPI is triggered.
